Any Application form submitted 7 days before tryouts or submitted the day of tryouts will be subject to a \$230/\$130 application fee.

Any player placed on Team 1 or Team 2 that attended the Team 1 tryout will have \$100 of the Application for Membership fee applied to their Membership fees.

All players trying out must attend the tryout for their appropriate age group. No player will be permitted to tryout at an older age group.

No player will be allowed to participate in any practice or scrimmage until we receive your registration confirmation.

TERMS OF APPLICATION FOR MEMBERSHIP, REGISTRATION AND COMMITMENT 2010 – 2011

I (we) agree to pay a \$200 (\$230 the day of tryouts) for Team1 tryout or \$100 (\$130 the day of tryouts) for the General tryout Application fee and a \$250 Commitment fee in consideration for participation in the AFHA 2010–2011 Pre-Season Player Evaluations (i.e. tryouts). Any player who's Application for Membership is accepted and placed on an Arctic Foxes Team will be notified of placement by posting on the AFHA website at www.arcticfoxes.org. Team 1 posting dates are as follows: Mite & Squirt 4/21/10; Pee Wee and Bantam 4/27/10; Midget 5/7/10. Posting dates for general tryouts are as follows: Mite & Squirt 4/30/10; Pee Wee 5/10/10; Bantam 5/7/10; Midget 5/17/10. Players opting to decline placement must do so by e-mail to Michelle Parks at mparks5@comcast.net by the following dates: **Team 1: Mite & Squirt 4/24/10; Pee Wee and Bantam 4/30/10; Midget 5/10/10. General tryouts: Mite & Squirt 5/3/10; Pee Wee 5/13/10; Bantam 5/10/10; Midget 5/20/10.** If a player is not placed on a team, \$50 of the Application fee and the \$250 Commitment fee will be returned. For players placed on teams, the Application fee is non-refundable. **The aforementioned Commitment fee will be refunded only if a player declines his/her placement as required by the date specified; otherwise, the Commitment fee is non-refundable.**

3. I (we) agree to pay all fees as listed in the 2010–2011 fee schedules herein and acknowledge that they are non-refundable and may not be waived. If a player withdraws from AFHA membership or if membership is terminated for any reason, all fees paid are forfeited and payment of any unpaid fees is accelerated and becomes immediately and fully due and payable.
4. I (we) agree that I (we) are financially responsible for the purchase and maintenance of two (2) sets of AFHA game jerseys and socks, (1-home, 1-away) and for the return and/or replacement and repair of any equipment that may be assigned, which is lost, stolen or damaged beyond reasonable wear and tear in the field of play.
5. Offer of Membership: By signing this document I (we) agree and understand that:
 - a. It does not constitute a guarantee of an offer of membership or placement;
 - b. Membership in the AFHA is a privilege and conditional upon an offer of membership and placement extended by the AFHA within the sole discretion of the AFHA Board of Directors;
 - c. Placement of Players is made upon the recommendation of the AFHA Evaluation Committee; and
 - d. Players and Parents/Legal Guardians shall abide by all USA Hockey, MidAm, PAHL and AFHA policies, rules and regulations, including, but not limited to those referenced within the AFHA "Player/Parent/Legal Guardian Handbook", as well as satisfy all financial obligations.

- A \$100 sibling discount will be given for each additional child when more than one member of the same family plays for the Arctic Foxes.
- Mite & Squirt Only – If a team has 2 goalies and they want to skate out when they are not in net, they must pay the full player fee.
- If a player fails to decline his/her placement as required by the date specified, the Commitment fee is non-refundable.
- If a player withdraws from AFHA membership or if membership is terminated for any reason, all fees paid are forfeited and payment of any unpaid fees is accelerated and becomes immediately and fully due and payable.
