### TERMS OF APPLICATION FOR MEMBERSHIP, REGISTRATION AND COMMITMENT

2011 – 2012

PLEASE NOTE:       **(A)** All Tryout Fees and Commitment Fees are due at time of registration. Please contact Treasurer (Scott Sroka) at [treasurer@arcticfoxes.org](mailto:treasurer@arcticfoxes.org) with any questions.  
**(B)** Online registration is the only way to register for tryouts. No paper applications will be accepted.  
**(C)** Registration will cease 24 hours prior to the first tryout (Squirt registration will close on May 6<sup>th</sup> 8:00 am, PW Registration will close on May 1<sup>st</sup> 6:30 pm, Bantam Registration will close on May 6<sup>th</sup> 11:00 am and Midget Registration will close on May 4<sup>th</sup> 6:30 pm)  
**(D)** NO WALK-UP REGISTRATIONS WILL BE ACCEPTED!

1. All players trying out must attend the tryout for their appropriate age group. No player will be permitted to tryout at an older age group.
2. I (we) agree to pay \$125 for the Tryout Application fee and a \$300 Commitment fee in consideration for participation in the AFHA 2011–2012 Pre- Season Player Evaluations (i.e. tryouts). Any player who's Application for Membership is accepted and placed on an Arctic Foxes Team will be notified of placement by posting on the AFHA website at [www.arcticfoxes.org](http://www.arcticfoxes.org). Posting dates are as follows: Squirt 5/19/11; Pee Wee 5/18/11; Bantam 5/20/11; Midget 5/20/11. Players opting to decline placement must do so by e-mail to Scott Sroka at [treasurer@arcticfoxes.org](mailto:treasurer@arcticfoxes.org) and Todd Mclean at [coachtoddm@verizon.net](mailto:coachtoddm@verizon.net) by the following dates: Squirt 5/22/11; Pee Wee 5/21/11; Bantam 5/23/11; Midget 5/23/11.
3. If a player is not placed on a team, \$50 of the Application fee and the \$300 Commitment fee will be returned. For players placed on teams or those who decline placement on a team before final postings are made, the \$125 Application fee is **NON\_REFUNDABLE**. The aforementioned Commitment fee will be refunded only if a player declines his/her placement as required **by the date specified; otherwise, the Commitment fee is non-refundable**.
4. I (we) agree to pay all fees as listed in the 2011–2012 fee schedules herein and acknowledge that they are non- refundable and may not be waived. If a player withdraws from AFHA membership or if membership is terminated for any reason, all fees paid are forfeited and payment of any unpaid fees is accelerated and becomes immediately and fully due and payable.
5. I (we) agree that I (we) are financially responsible for the purchase and maintenance of two (2) sets of AFHA game jerseys and socks, (1- home, 1- away) and for the return and/or replacement and repair of any equipment that may be assigned, which is lost, stolen or damaged beyond reasonable wear and tear in the field of play.

6. Offer of Membership: By signing this document I (we) agree and understand that:
  - a. It does not constitute a guarantee of an offer of membership or placement;
  - b. Membership in the AFHA is a privilege and conditional upon an offer of membership and placement extended by the AFHA within the sole discretion of the AFHA Board of Directors;
  - c. Placement of Players is made upon the recommendation of the AFHA Evaluation Committee;
  - d. Players and Parents/Legal Guardians shall abide by all USA Hockey, MidAm, PAHL and AFHA policies, rules and regulations, including, but not limited to those referenced within the AFHA "Player/Parent/Legal Guardian Handbook", as well as satisfy all financial obligations.
7. In consideration of my participation and/or the participation of my child in the  
Pre- Season Player Evaluations, I (WE) KNOWINGLY ASSUME ALL RISKS AND  
HAZARDS THEREOF, including, but not limited to those known and/or unknown,  
foreseen and/or unforeseen. Further, I agree to release, defend, indemnify and hold  
harmless the AFHA, its Board of Directors, Officers, agents, servants and all other  
representatives and members, as well as USA HOCKEY, INC., from

any and all liability, loss, expense, attorney's fees and claims for injury, death or damage which in anyway relate and/or refer to Participation in Pre- Season Player Evaluations.

\*Goaltenders may optionally register for seven 45 minute goalie lessons with Shane Clifford.

The cost of these lessons will be added to the cost of your 2011- 12 Membership Fee.

- The annual membership fees are based on teams consisting of 15 skaters and a minimum of 1 goalie. If a team has less than 15 skaters, the fee for the additional players needed to

equal 15 skaters, will be prorated to the existing skaters on the team.

- A \$100 sibling discount will be given for each additional child when more than one member of the same family plays for the Arctic Foxes.
- If a team at the Squirt Level has 2 goalies and they want to skate out when they are not in net, they MUST pay the full player fee. Goalies on Pee Wee, Bantam and Midget Teams are NOT permitted to skate out, under any circumstances.
- If a player fails to decline his/her placement as required by the date specified, the Commitment fee is non- refundable.
- If a player withdraws from AFHA membership or if membership is terminated for any reason, all fees paid are forfeited and payment of any unpaid fees is accelerated and becomes immediately and fully due and payable.
- Credits to player accounts for working at Pirates Games and/or First Niagara Pavilion Concerts will be done after the last respective game/concert. After such credits are applied to your account, if there is any remaining balance owed to AFHA for Membership Fees, it will be pro- rated over the time remaining in the installment payment plan and billed to the credit card or e- check account that is submitted during registration.
- Fees and Fundraiser Credits are non- transferable between players.
- Any change to your email address or credit card/checking account information MUST be communicated to the Treasurer via email at [treasurer@arcticfoxes.org](mailto:treasurer@arcticfoxes.org) IMMEDIATELY.
- Any scheduled Membership Fee payments or any other payments to AFHA of any type that are refused for insufficient funds or chargeback are subject to a \$35 fee.
